Admission Notification

Online Applications are invited from Indian Citizen in prescribed form for admission to B.Ed. Course for the session: 2023-25.

A) GENERAL INFORMATION

1. Applications are invited for 2 years B.Ed. Programme: 2023-25.
2. Total no. of seats: 100 (**05 Deputed + 95 Fresher**). Deputed vacant seats (if not found) will be converted to fresher seats (as per category). Reservation policy of Govt. will be followed strictly (for details see seat distribution).
3. As per Govt. order no. 372-Edn(CS)/10M-20/2015, dated 08.06.2023, ratio for home University (Vidyasagar University) students and Other University students shall be 80:20.
4. All applications must be made **ON-LINE** through given website: www.bed.tmv.ac.in on and from **01.09.2023 to 12.09.2023** (up to **11.59 pm**).
5. **No Application fees** will be charged as per Govt. order no. 372-Edn(CS)/10M-20/2015, dated 08.06.2023
6. Course Fees-
 - i) For fresher candidate- Rs. 54,000/- (1st year – Rs.30,000/-, at the time of counselling cum admission + 2nd year- Rs. 24,000/-).
 - ii) For Deputed candidate- Rs. 80,000/- (1st year – Rs.40,000/-, at the time of counselling cum admission + 2nd year- Rs. 40,000/-)

N.B:

- Mode of payment for course fees through e-payment method (**Credit Card / Debit Card / Net Banking / RTGS / NEFT**)
- Scanned copy of payment receipt (if payment made by **NEFT/RTGS**) must be uploaded within the stipulated date strictly and the admission process will be completed after verification of payment receipt.

7. All testimonials (scanned copies) are required to be uploaded during online application.

Verification of documents will be done only when the students report for the classes in due course. Admission will be canceled if the documents are found not in conformity with the declaration in the forms submitted on-line.

B) ELIGIBILITY:

- i) Candidates (both Fresher & Deputed) with at least 50% marks either in Bachelor's Degree and /or in Master's Degree for General Category whereas it is 55% for BE /B. Tech. with specialization in Science and Mathematics. While in case of SC/ST/PH Category 45% (50% for BE / B. Tech. with specialization in Science and Mathematics) marks either in Bachelor's Degree and /or in Master's Degree in Arts / Science / Commerce.

N.B: For General candidates (having only Hons. Degree) with less than 50% marks in the honours' subject, the aggregate marks (Hons. subject +Pass subjects + Compulsory subjects) will be considered as general/pass category, if it becomes 50% or more. For SC/ST/PH candidates - 45%

- ii) Fresher Candidates can select only one pedagogy subject at the UG or P.G level of the available pedagogy subjects.

- **Pedagogy of Language Teaching:** Bengali, English, Sanskrit (only one school subject be taken)
- **Pedagogy of Social Science Teaching:** History, Geography, Political Sc. Education, Sociology, Philosophy, Commerce. (Only one school subject be taken)
- **Pedagogy of Science Teaching:** Physical Science, Life Science, Computer Science & Application, Food & Nutrition. (Only one school subject be taken)
- **Pedagogy of Mathematics Teaching:** Mathematics.

- iii) **Fresher Candidates (General)** must be within 38 years of age as on **30.06.2023**. There shall be a relaxation of 5 years in case of SC/ST/PH candidates.

- iv) **Deputed Teachers Teaching for Class-(v) to (xii) (Pass or Hons. Graduate /PG Scale)** in W.B. Govt. Aided Institution having at least **one year** teaching experience as on **30.06.2023** are eligible. Para-teacher / Primary teachers are not eligible as deputed candidate.

- v) **Candidates pursuing any other Course of Studies/Job/Full- time Research Work will not be allowed to pursue this course simultaneously.**

C) HONOURS OR PG / PASS OR GENERAL CATEGORY:

- i) If the candidates have obtained B.A (Hons.) / B.Sc. (Hons.) / B. Com (Hons.) / B.E. / B.Tech. and /or post graduate degree (including MCA), then he/ she will be treated as **Hons. / PG Category**.

Stream for BE / B.Tech: The highest academic degree obtained by the candidate will be treated as his / her stream (upto PG degree). B.E./ B.Tech. degree with specialization in Science and Mathematics holder are treated as science stream.

- ii) If the candidates have obtained B.A./B.Sc./B. Com (Pass/General)/BCA/B.Sc. (Voc.) degree in UG and no PG degree, then he/ she will be treated as **Pass/General category**.

- iii) If the candidates have obtained both B. A/B.Sc./B. Com (pass/gen) & PG degree, then he/She will be treated as **Hons. / PG category**.

iv) **DEPUTED:**

Teachers teaching in conventional Arts and Commerce subjects will be treated as Deputed/Arts-Commerce category and teachers teaching in science subjects will be treated as Deputed/Science category.

[Minimum eligibility criteria (as per NCTE Norms, 2014) is 50% or 45 % (as the case may be) marks either in Bachelor's degree and/or in the Master's Degree.]

- **FRESHER:** [Candidate type/University category/caste/Stream/Qualification Type]:
e.g. - F/VU/Gen./Arts/Hons. /P.G
- **DEPUTED:** [Candidate type/University category/Caste/Stream/Qualification Type]:
e.g. - D/VU/Gen./Sci./Hons. /P.G

D) **ACADEMIC QUALIFICATION:**

The candidates should take special care while providing information to this section/table. They should clearly understand marks obtained and full marks.

1. **Madhyamik or equivalent:** Fill the row with appropriate data including marks obtained and full marks excluding additional subjects if any.
2. **H.S. or equivalent:** Fill the row with appropriate data including marks obtained and full marks in the best five subjects including Bengali & English, in case of a new grading system the marks of Environmental Studies will be excluded.
3. **Undergraduate:** Before CBCS system candidates having Honours in (UG) degree level will be awarded grade only for **Total Marks in Honour's subject**. In case of Pass/general degree holders **marks obtained in aggregate** (in all general papers including compulsory papers) will be considered.

N.B: For General candidates (having only Hons. Degree) with less than 50% marks in the honours subject, the aggregate marks (Hons. subject +Pass subjects + Compulsory subjects) will be considered as general/pass category, if it becomes 50% or more. For SC/ST/PH candidates - 45%.

- a) In case of candidates awarded **with grade / CGPA in UG, equivalent % of marks may be calculated based on the University/boards formula and from there, marks obtained out of 1000** may be considered for filling the marks obtained and full marks. In such cases, there should be proper document / mention in the mark sheets regarding conversion of grade / CGPA to % of marks.
In case of Vocational Candidates / BCA (who are considered as pass graduates), marks obtained in all the examinations Part-I, II & III will be considered and marks obtained should be rightly calculated.

4. **Postgraduate:** If the candidates have completed PG degree and are applying in Hons-PG category, fill this row (PG) with appropriate data including marks obtained and full marks. In case of candidates **awarded with grade / CGPA in PG, equivalent % of marks may be calculated based on the University/boards formula and from there, marks obtained out of 1000** may be considered for filling the marks obtained and full marks. In such cases, there should be proper document / mention in the mark sheets regarding conversion of grade to % of marks.

Similarly, if a candidate has both M.A & M.Sc. degrees in two different subjects then the qualification acquired later will be considered for determining his category and grade calculation.

5. **M.Phil./ Ph.D. degree:** In any Subject

N.B: For Deputed Teachers

- i) Deputed Teachers (Must submit certificate from HM that he/she is teaching from class(v) onwards) in Hons. Scale having PG degree should fill rows corresponding to Honours graduate (**Total Marks in Honour's Subject**) and also the row for PG (Marks in P.G). However, for eligibility % of marks, Hons. or PG degree will be checked. For teachers in PG scale, eligibility % of marks will be checked either in UG or PG and academic grade will be awarded for both UG and PG degree.
- ii) Deputed Teachers in Pass scale having Hons. Degree and /or PG degree should fill rows corresponding to Hons. Graduate and the row for PG (if he/she has PG degree). However, for eligibility % of marks, Pass, Hons. and PG % will be checked.

[Minimum eligibility criteria (as per NCTE Norms, 2014) are 50% or 45 % (as the case may be) marks either in Bachelor's degree and/or in the Master's Degree.]

E) UNIVERSITY TYPE: (VU / OU):

- i) Whether a fresh applicant shall fill up online application form of either Vidyasagar University Category or Other University category that will be determined based on the Mark Sheet (which has been uploaded during online application) of the last Examination passed or the last Certificate (in case of M.Phil. or Ph.D. holders)
- ii) A candidate who has obtained PG degree from Directorate of Distance Education of Vidyasagar University will be treated as 'Vidyasagar University' Candidate.

F) SELECTION PROCEDURE:

- a) **For Deputed Candidates**, Provisional Rank shall be prepared based on their **Approved Length of Service** as on **31.08.2023**. In case of the same length of service of two or more candidates, the 2nd and 3rd criteria shall be **Total Grade marks** and **Date of Birth** respectively.
- b) **For Fresh Candidates**, subject wise Provisional Rank shall be prepared based on their Academic Grade Marks to be computed as per the following norms:
 - i. 10% of the percentage of marks obtained at the M.P.(S.E.) or Equivalent Examination.
 - ii. 10% of the percentage of marks obtained at the H.S. (10+2) or Equivalent Examination.
 - iii. : a) 15% of the percentage of marks obtained at the B.A./B.Sc./B.Com.-Gen./Pass) Examination. or,
b) 20% of the percentage of marks obtained at the B.A./B.Sc./B.Com. Hons. Or equivalent Examination [% of marks obtained in this case shall be computed considering the marks of Hons. subject only.]

For General candidates (having only Hons. Degree) with less than 50% marks in the honours subject, the aggregate marks (Hons. subject + Pass subjects + Compulsory subjects) will be considered. If it becomes 50% or more, that aggregate marks will be entered in graduation (general/ pass) row. For SC/ST/PH candidates 45%.

N.B: [Minimum eligibility criteria (as per NCTE Norms, 2014) are 50% or 45 % (as the case May be) marks either in Bachelor's degree and/or in the Master's Degree.]

- iv. 20% of the percentage of marks obtained in B.E./B.Tech. or equivalent examination.

N.B: Bachelor's in Engineering or Technology with specialization in Science and Mathematics with least 55% marks, or any other qualification equivalent thereto, are eligible for application. (NCTE, 2014)

- v. 20% of the percentage of marks obtained at Post Graduate Examination.
- vi. a) 3 marks shall be awarded for M. Phil. Degree.
b) 5 marks shall be awarded for Ph.D. degree.
c) Candidates with M.Phil. & Ph.D. degrees both, only 5 marks will be awarded. (Only Ph.D. degree will be considered)

G) FINAL MERIT LIST, COUNSELING AND ADMISSION:

- i) The final merit list will be published after the complaints are considered within the stipulated date.
- ii) Online counseling will be held based on Final merit list and admission fees must be deposited through online payment method (Credit Card /Debit Card / Net Banking / RTGS / NEFT) within stipulated date strictly.
